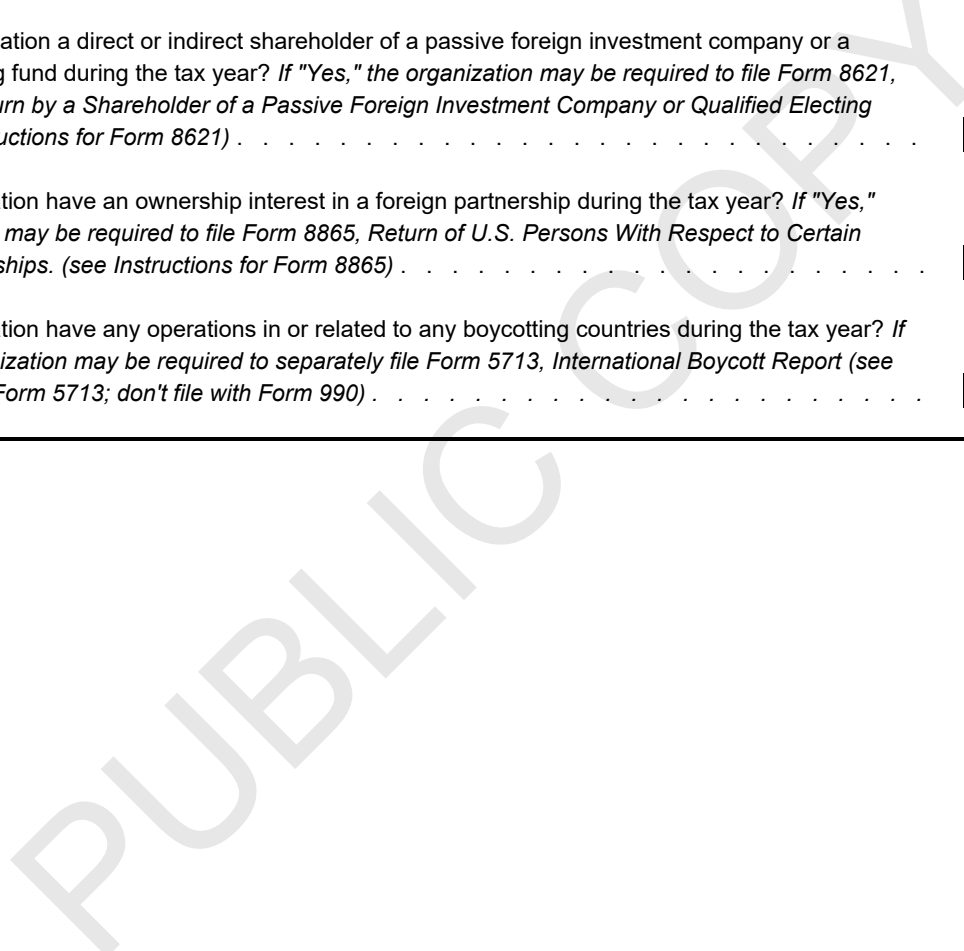

Part I Line 2 Save the Manatee Club provides restricted grants and other non-cash assistance to other organizations in the United States and overseas that are providing Manatee Rescue and Rehabilitation services, for specific programs/projects or for the rehabilitation of Manatees to be released into the wild following their Recovery. Cash grants are made for reimbursement of expenses already incurred or restricted for the purchase of supplies urgently needed for ongoing Manatee Rescue and rehabilitation. Non-cash assistance is also provided, including the provision of supplies, equipment, training or staff expertise.

Part I Line 2 When funds are issued for reimbursement of incurred expenses, the requesting organization provides documentation of a program services expense (related to Manatee Rescue and rehabilitation) and funds are transferred by check or electronic funds transfer.

Part I Line 2 Funds for future expenditure are made either (A) purchase specific supplies or equipment needed for Manatee rescue, or (B) to purchase food for a rescued Manatee. The request includes a statement of the cost of the needed equipment, food, or supplies and its necessity for ongoing Manatee Rescue and Rehabilitation. Funds are disbursed by check or electronic transfer. Use of the funds for the specific purpose is verified by documentation by the recipient organization and/or by in-person inspection by a Save the Manatee Club staff member or authorized volunteer at a future visit.
